



Four new grants awarded

In 2021, JCH was awarded 4 new federal grants. The funds awarded total more than \$2,000,000. About \$500,000 of these grant funds will be distributed and the grants completed in one year and the remaining \$1,500,000 will be over a three year grant period. Within these grants, 7 full time positions are funded.

Two of these grants will allow for the further growth of the JCH Medication-Assisted Treatment Clinic, one will provide funds to strengthen the JCH Emergency Medical Service System and finally, and the third created the opportunity for JCH to partner with the health departments of Jersey, Calhoun and Greene counties to create the Tri County Preventative Health Alliance.



IMPROVED AND EFFICIENT WORKFLOWS

Negative Pressure Rooms



JCH has added negative pressure to 20 exam rooms in our hospital and clinics. Negative pressure rooms are used to isolate patients with contagious, airborne diseases such as measles, tuberculosis, or COVID-19 and are a common method of infection control. Negative pressure rooms are especially important to mitigate risk of COVID-19 transmission to healthcare workers.

The spaces are called negative pressure rooms because the air pressure inside the room is lower than the air pressure outside the room. When the door to the negative pressure room opens, contaminated air does not flow out. Instead, filtered air flows in and the potentially contaminated air is sucked out. This air is then filtered before it is pumped back out and away from the healthcare facility.

New Call System

To save time and prevent possible exposure to COVID-19, each hospital department now uses one consistent call system to better communicate with patients in real time. When the patients press the call button, they then speak directly to a staff member through an intercom system.

This technology reduces potential staff exposure to COVID-19 while enhancing workflow to conserve time and clinical resources. Patients like it because it allows them to communicate faster.



Updates to Central Sterile and Operating Rooms

In our Central Sterile area, the sinks, washer/disinfector and autoclave were replaced with the newest models.

Upgrading this equipment improves workflow in the department by offering high-level disinfecting for all surgical instruments used in and outside of the Operating Room.

Also pictured are the upgrades made to the Operating Rooms. The newly formulated epoxy on the floors and walls along with the upgraded ceilings provide for faster, more efficient sterilization.

Both Central Sterile and Operating Rooms received lighting upgrades to increase efficiencies in sterilization.



CERTIFIED NURSING ASSISTANT COURSE



The JCH Foundation provided \$9,000 in funding to cover tuition and materials to make it possible to bring the Lewis and Clark Community College Certified Nursing Assistant (CNA) course to JCH.

Upon completion of this one semester course, the 10 local High School students enrolled in the course will have obtained their certification and will be able to work as a Nursing Assistant in a healthcare setting.

EMT TRAINING COURSE

Utilizing funds awarded through the SAMHSA EMS Training Grant, JCH was able to offer a Basic Emergency Medical Technician (EMT) course at no charge to 19 individuals interested in work in Emergency Medical Services.

Items covered by this grant includes text books, work books, training mannequins, staff salaries and travel/registration fees for staff.
